& AIMS

Each year we offer support to parents of gifted pupils whose circumstances would otherwise put an independent school education beyond their reach. We work closely with each of our partner schools in order to widen access, helping them to reach out to local families and supporting them through the process of identifying candidates.

These funds currently support students from prepreparatory level through to senior school. It is the intention of the Trustees to extend support into tertiary education, subject to suitable candidates being found.

The Charity also operates as an essential support mechanism for the children of

All bursaries are means tested and are reviewed annually. Awards range from 10% to 100% fee remission. We want to identify untapped talent irrespective of parental means, to nurture potential and to develop character and attitude. In the process, we want to change lives for the better.

Series of School History Talks

Nigel Watson, the author of the book commissioned by the Trust, The Story of St. Anthony's, gave a series of talks on the history of the school, to current and former parents, alumni and current students. This was also an opportunity to sell a number of copies of the book which were much sought after.

All proceeds support the school's bursary fund.

The History of Wetherby - 90 Years On

The Story of St. Anthony's, which came on sale in 2018 to mark the school's 125th anniversary, continues to be a great success both in reengaging alumni with their former school, and as a marketing tool for current and prospective parents.

On the heels of this success, a history of the Wetherby Schools is underway, with proceeds from sales to go to support bursaries. Interviews with former and current pupils and staff, from across the Wetherby Schools, took place in the summer and autumn terms. Alumni and former staff are helping to build school archives of visual materials to include in the book.

The book will be published in 2021, to coincide with the Wetherby School 90th Anniversary.



Alumni Reunions

Informal alumni reunions are proving an effective method of engaging alumni. Schools and Colleges continue to invite alumni to regular events. Notably, Carol Services and Remembrance Services.

During the last two weeks of March a series of alumni reunions for Old Antonians were held at St. Anthony's School for Boys.

These inaugural events for the St. Anthony's School Association included

representation from each decade from the 1940s through to the 1990s. Many alumni brought memorabilia to donate to the school archives as well as memories and stories to share with their former classmates. The school was thrilled with the turnout.

John Withers Retires

The occasion of John Withers' departure from Hilden Grange - after 34 years of outstanding service at the school, including 29 years as Headmaster - was used to engage with and sign up scores of alumni to the new Hilden Grange alumni website.

It was really wonderful to see everyone reminicise about their school days, explore upon the changes to the school and catch up with old friends.

Springboard Foundation

The GSCT has started working with the Royal National Children's Springboard Foundation, a charity that ordinarily identifies bursary candidates to match to partnered boarding schools. In our case, Springboard is working with the GSCT to help the Trust identify candidates for whom a boarding school environment is considered unsuitable, or where a day school is preferred by the applicant family.

We will look to provide places within the Alpha Plus Group for these bursary candidates.

Towards the end of this year, the GSCT formed a partnership with Kindergifts; an invitation platform that enables children to share their celebrations with a charity of their choice. The Gold Standard Charitable Foundation (US)

TRUSTEES

Sir John Ritblat Chairman

Sir John Ritblat Hon DSc, is the Honorary President of The British Land Company PLC, Chairman of Delancey's Real Estate Advisory Board, and Chairman of the Alpha Plus Group.

In 2019, The Sir John Ritblat Family Foundation enabled the creation of The Sir John Ritblat Chair at Oxford University for a Professorship in Mindfulness and Psychological Science.

He stood down as Chairman of the Board of Governors of London Business School in April 2014 after 23 years on the Board and 10 years as Chairman. He remains on the Estates Committee, as a Member of Distinguished Friends and is an Hon Fellow.

He was previously Chairman of the Wallace Collection and a Trustee for 10 years and remains Chairman of The Foundation.

He is an Hon Fellow and Hon Trustee, and was Deputy Chairman of the Royal Academy of Music.

Sir John is Hon President and Member of The British Library Fundraising Advisory Group and President of the British Library's Living Education fundraising campaign. He previously served as a Board Member from 1995-2003, and then served again from 2015-2019 during the period of its move from The British Museum to its new home in Euston Road. He endowed "The Sir John Ritblat Gallery, Treasures of The British Library".

He is the President of British Ski & Snowboard National Foundation. In his different guises he has been the principal sponsor of The British National Alpine Ski Championships for the last 42 years and is the longest serving Sponsor in British Sport. He also helped to establish the governing body for all British snow sport athletes which is now known as GB Snow Sport Federation.

He is Vice President of the Real Tennis & Racquets Association

Colin Wagman FCA

For over 30 years, Colin Wagman has been extensively involved in the UK property industry. As former Deputy Chairman of Delancey and its CFO he was responsible for their treasury and finance functions as well as their corporate and taxation policies.

Colin holds several non-executive directorships and is Chairman of The City of London Group Plc, as well as being a trustee of several charities and was a founding trustee of The Silver Line Helpline.

He was also closely associated with the property and finance industries throughout his 28 years in public practice as a Chartered Accountant and was a Senior Partner in the firm Casson Beckman in London until he retired from practice in 1991.

Colin is a Fellow of the Institute of Chartered Accountants in England and Wales, having been admitted as an Associate in 1970.

Howard Goldsobel

Howard Goldsobel is a partner in a West End firm of solicitors specialising in company and commercial work. Howard has a lifelong interest in educational affairs and was a Lay Inspector of Schools from 1993 to 2001.

A keen reader, a tennis player and skier, Howard holds an MBA and was from 2008 until 2019 a foundation Governor and Chair of Resources at a VA faith school.

Julietta Gishen

Following a brand management career at the BBC, Julietta took over the administration of the Charity in 2012. After becoming a mother to four children and entering three in private schools across London, she was appointed as a Trustee.

Over the last six years, she has built solid relationships with the Heads and has helped to facilitate the allocation of bursaries and hardship funding to students across the GSCT schools.

TRUSTEES

Graham Able

Graham Able is currently Deputy Chairman for the Alpha Plus Group having stepped down from his role of CEO from October 2009 – June 2014. Graham took over as CEO of the Alpha Plus Group two months after he retired as Master of Dulwich College in 2009 and after 40 years in independent schools, the last 21 of which was spent in Headships.

Prior to his nearly 13 year tenure at Dulwich College, Graham was Head of Hampton School. He has been closely involved in the independent sector in London for over 25 years.

Graham is a former chairman of HMC which represents the Heads of over 250 of the leading independent schools in the United Kingdom. He also chaired the HMC/Girls' Schools Association (GSA) joint academic policy committee and was President of the International Boys School Coalition for three years until July 2009 (the first non-American to hold this post).

During his Mastership at Dulwich, Graham was responsible for the development of the Dulwich schools in China and remains Senior Vice-President of Dulwich College Management International. Most recently, he has co-founded the lobbying group, Exporting Education (UK), which he chaired up until 18 months ago.

Dr Martin Stephen

Dr Martin Stephen was educated at Uppingham School in Rutland followed by the University of Leeds and then the University of Sheffield where he obtained a PHD. He was Headmaster of The Perse School, Cambridge (1987–1994), High Master of Manchester Grammar (1994–2004) and then High Master of St Paul's School (2004–2011). He was Chairman of The Headmasters' and Headmistresses' Conference in 2004.

Martin has a long history of charitable fundraising, raising £10 million for bursaries at Manchester Grammar and £30 million for redevelopment at St Paul's School.

Martin is a prolific author of several academic titles on English Literature and five Henry Gresham crime novels set in London and Cambridge. Following a stroke in 2005 he wrote about his experiences in a work titled 'Diary of a Stroke'. Martin is a founding governor of The London Academy of Excellence.

Dr Priscilla Chadwick

Having been Head of Religious Education and Principal in both state comprehensive and independent schools, as well as Dean of Educational Development at South Bank University, Dr Chadwick was the first woman elected as Chairman of The Headmasters' and Headmistresses' Conference (HMC).

She is a governor of a number of independent schools and academies. She chaired the National Dioceses Commission for the Archbishop of Canterbury, presented 'Thought for the Day' for BBC Radio 4, led a major review of Church schools for the Church of England and published two well-reviewed books on education.

Her interests include music, the arts and world travel.
